I, Kalyani Srinivasan, Practising Company Secretary (CP No.6047), Chennai, was appointed as "the Scrutinizer" by the Board of Directors of M/s. TANFAC INDUSTRIES LIMITED in their meeting on 7th August 2020, in connection with their 46th Annual General Meeting of the Members held on Monday the 28th September, 2020 at 11.30 a.m. through video conferencing / other audio visual means in accordance with the circulars issued by the Ministry of Corporate Affairs and Securities and Exchange Board of India (deemed to be held at the Registered Office of the company at Plot No.14, SIPCOT Industrial Complex, Cuddalore - 607 005), for the purpose of scrutinising the remote e-voting and e-voting during the meeting in a fair and transparent manner. Also, to ascertain the requisite majority on remote e-voting and e-voting during the meeting carried out as per the circulars issued by MCA and SEBI and also the provisions of The Companies Act, 2013 and the rules made there under providing relaxation for the manner in which the AGM shall be held and conducted. The MCA & SEBI CIRCULARS provides for relaxation in the manner in which the AGM will be held including the manner of sending the Notices and Annual Reports to the shareholders and the manner of voting at the meeting, which was necessitated on account of the outbreak of COVID -19 (CORONAVIRUS) pandemic. I am familiar and well versed with the concept of electronic voting system as prescribed under the said Rules and the relaxations as provided in the MCA & SEBI Circulars .

As mentioned in the Notice the proceedings of the AGM will be deemed to be conducted at the Registered Office of the Company which shall be the deemed Venue of the AGM.

The Management of the Company is responsible to ensure compliances as required under the Companies Act, 2013 and the rules made there under in relation to exercising of voting rights through electronic means (i.e. remote e-voting and poll) on the resolution(s) as set out in the Notice convening the 46<sup>th</sup> Annual General Meeting (AGM) dated 7<sup>th</sup> August, 2020.

My responsibility, as a Scrutinizer for the e-voting process and the e-voting during the meeting conducted at the 46<sup>th</sup> AGM, is restricted to make a Scrutinizer's report of the votes cast "in favour" of or "against" the resolution(s) set out in the Notice dated 7<sup>th</sup> August, 2020, convening the 46<sup>th</sup> AGM, based on the reports generated from the e-voting facility provided by the Central Depository Services (India) Limited (CDSL), the authorised agency engaged by the Company for providing e-voting plat form facilities and also at the time of poll conducted at the venue of the AGM.

In view of the above, I submit my report as a scrutinizer as under:

The Company had appointed Central Depository & Securities Limited (CDSL) as the service provider for the purpose of remote e-voting and e-voting at the meeting.

The service provider had set up electronic voting facility on their website, https://www.evotingindia.com. The Company had uploaded all the items of the business to be transacted at the AGM on the websites of the Company, the Service Provider and BSE Limited (stock exchange where the shares of the Company is listed) to facilitate their Members to cast their vote through Remote E-Voting.

The remote e-voting period remained open from 9.00 a.m. on Friday the 25<sup>nd</sup> September, 2019 and ended upto 5.00 p.m. on Sunday the 27<sup>th</sup> September, 2020.

The Shareholders holding shares as on the "cut off" date i.e. 21<sup>th</sup> September, 2020, were entitled to vote on the proposed Four Ordinary Resolutions and One Special Resolution as contained in the Notice dated 07<sup>th</sup> August, 2020, of the 46<sup>th</sup> Annual General Meeting (AGM) of the Company. The Company had sent the Annual Report and the Notice to the 46<sup>th</sup> AGM by email to the registered shareholders as on 4<sup>th</sup> September 2020, the cut-off date for the purpose of sending the Notice and the Annual Report for the AGM.

Valid votes have been cast by the Members through electronic voting system. The votes were unblocked as per the applicable provisions of the Companies Act, 2013 and Rules made there under.
